3. **Recommendations** – Submit required letters of recommendation.
4. **Financial** – Attach most recent IRS return or tax statement.
5. **Essay** – Attach one page essay on required topic.
6. **Sending** – You may fax, deliver or mail the application package to the Community Foundation of Collier County ATTN: Annette Kirk by the due date.

Scholarship monies will be paid directly to the Post-Secondary Institution upon receipt of Scholarship Recipient Form, which is completed by the Student and/or Counselor. Student must send Recipient form and verification of enrollment by August 1st for fall semester, by December 1st for spring semester and by April 1st for summer semester to CFCC or scholarship monies will be forfeited.
